VOLUNTARY WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY AGREEMENT, AND PHOTO RELEASE



Thank you for electing to participate in one or more projects for the MLK Multifaith Day of Service. Please read this Voluntary Waiver of Liability, Assumption of Risk, and Indemnity Agreement, and Photo Release Agreement (“Agreement”) carefully before signing. If you are under the age of 18 years, the parent or legal guardian will also need to read and sign (or agree by electronic means to) this Agreement.

I, the undersigned, intend to perform voluntary services without compensation for the MLK Multifaith Day of Service on January 15, 2024. I understand and acknowledge that my involvement and participation in the MLK Multifaith Day of Service carries with it the risk of personal injury and/or property damage. I have read the project descriptions(s) for the project(s) in which I intend to participate and am aware of the possible hazards. I understand that the specific risks vary from one activity to another and include (1) minor injuries, such as scratches, bruises, and sprains; (2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions (3) catastrophic injuries, including paralysis and death, and (4) damage to or loss of personal property.

The COVID-19 virus is a worldwide pandemic. As a result, federal, state and local governments and agencies recommend social distancing and have restricted in-person gatherings. PMC is doing everything possible to be compliant with all regulations and ensure your safety. Nonetheless, PMC cannot guarantee that any or all of the measures PMC is taking will protect you from contracting the COVID-19 virus during your participation in MLK Multifaith Day of Service.

I have read the paragraphs above and now understand, and appreciate the risks that are inherent in my participation in the MLK Multifaith Day of Service, including, without limitation, and for their members, directors, officers, agents, employees, partners, contractors, successors, and assigns, and the hosts of the specific projects for the MLK Multifaith Day of Service, including, without limitation, the owners whose property is used, their respective affiliates, officers, employees, partners, shareholders, members, contractors, agents, successors and assigns (collectively, the “Related Parties”) from any and all claims arising from or related to my participation in the MLK Multifaith Day of Service, including, but not limited to, personal injury, illness, accident, death, property loss, property damage, and

disease from COVID-19 even when such claims result from the negligence of and for the Released Parties.

If I choose to use my vehicle to drive any volunteers to or from MLK Multifaith Day of Service activities, I certify that I hold a current U.S. valid driver's license and I and my vehicle are insured as required by California Law.

I agree to indemnify and hold harmless the Released Parties from and against any and all claims made by me (or any of the Releasing Parties) as a result of my participation in the MLK Multifaith Day of Service. For the purposes of this paragraph, "claims" include all actions and causes of action, claims, demands, losses, costs, expenses, and damages, including legal fees and related expenses.

I grant the right, permission, and authority to Peninsula Multifaith Coalition, its members and congregations, contractors, agents, and representatives to record, photograph, film, and video me during the MLK Multifaith Day of Service and understand that any such photographs, motion pictures, recordings, quotes, and/or likenesses of me become the property of Peninsula Multifaith Coalition, Inc. and its Member Congregations. The Peninsula Multifaith Coalition, Inc. and its Member Congregations and their designees may use my name, image, likeness, quotes, and voice in connection with the MLK Multifaith Day of Service for any legitimate purpose, including, but not limited to promoting, advertising, and marketing activities.

No promise, inducement, or agreement has been made to me to induce me to release the Released Parties from liability as set forth in this Agreement, nor has any promise, inducement, or agreement been made to me in return for the express waiver of the rights referred to in this Agreement.

I HAVE READ THIS AGREEMENT AND FULLY UNDERSTAND ITS TERMS. I UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS, INCLUDING MY RIGHT TO SUE. I ACKNOWLEDGE THAT I AM SIGNING THE AGREEMENT FREELY AND VOLUNTARILY AND INTEND BY MY SIGNATURE TO PROVIDE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
